

## MIKE & MIKE'S DREAM FINALS 2017 SWEEPSTAKES

### OFFICIAL RULES

NO PURCHASE NECESSARY  
A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING

1. **PROMOTION DESCRIPTION:** Mike & Mike's Dream Finals 2017 Sweepstakes ("**Promotion**") consists of random draw sweepstakes. Entrants receive sweepstakes entries into a weekly drawing after correctly submitting a particular day's Winning Word as mentioned on the Mike & Mike show (the "**Weekly Sweepstakes**"). The Promotion runs on weekdays that the Mike & Mike show airs. It begins on May 8, 2017 at 6:00:00 AM Eastern Time ("ET") and ends on May 26, 2017 at 1:00:00 PM ET ("**Promotion Period**"). The Promotion provides entrants ("**Listeners**") with sweepstakes entries for the opportunity to win prizes as set forth below. This Promotion includes three (3) Weekly Sweepstakes drawings, giving Listeners the ability to enter through the web and text message. By participating in the Promotion, each participating Listener unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of ESPN Radio, a division of ABC Radio Network Assets ("**Sponsor**"), One ESPN Plaza, Bristol, CT 06010, and Dell Marketing L.P., One Dell Way, Round Rock, TX 78682 ("**Presenter**"), which shall be final and binding in all respects.

Sponsor is not responsible for any changes of a Listener's email address or phone number. In the event of a dispute, any Internet entries will be deemed to have been submitted by the Authorized Account Holder of the email address submitted at the time of registration, provided that person meets all eligibility requirements set forth in these Official Rules. "Authorized Account Holder" means the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address. Any Listener who attempts to participate with multiple email addresses, phone numbers, or under multiple identities will be disqualified from participation in the Promotion.

2. **HOW TO ENTER:** Each day that the Mike & Mike Show airs during the Promotion Period, a unique word (the "**Winning Word**") will be introduced at some point during the show, when it airs between 6:00 AM ET and 10:00 AM ET, Monday through Friday. Listeners can receive a total of two (2) entries per day, one for each entry method, when they submit the correct Winning Word before 1:00 PM ET each day, as follows: (a) submit the Winning Word through the entry form on [www.mikescontest.com/finals](http://www.mikescontest.com/finals); or (b) send a text message that includes the Winning Word to 777000. At the end of each weekly period, one (1) winner will be randomly selected from all valid entries received for that week from each daily entry period between 6:00 AM ET – 1:00 PM ET. Non-winning entries DO NOT roll over to subsequent prize periods/weeks. NOTE: for text entries, only texts to the specified number can win. Standard carrier-messaging and data charges may apply to each text message sent and received. Text messaging may not be available in all areas. Text messaging for free is available through services such as Google Voice and many other online services. By entering via text message, Entrant grants consent to: (1) text the cell phone used an acknowledgement message; and (2) call your cell phone should you be selected as a potential winner. Please consult your

carrier for applicable charges. Text messages may be sent through an automatic telephone dialing system to the mobile number provided. Consent is not required to purchase goods or services.

3. SWEEPSTAKES DRAWINGS and WINNER SELECTION:

The odds of winning any drawing depends on the number of eligible entries received.

WEEKLY WINNERS: One (1) potential Weekly Grand Prize Winner will be selected by random drawing from all eligible entries received for each of the following weekly periods:

- 5/22/17 – 5/26/17

Random drawings will be conducted by Sponsor, whose decisions are final. The potential Weekly Grand Prize Winners will be notified via email and/or phone, at Sponsor's sole discretion and prize award is subject to verification. Potential winner must respond to potential win notification within 48 hours or prize will be forfeited.

The potential winners will also be required to sign and return within three (3) business days: 1) an affidavit of eligibility; 2) a validly executed IRS Form W-9, because winner is responsible for any and all taxes due on the prize 3) a verification of age and 4) a publicity release where permitted (collectively, the "**Prize Claim Documents**") before being certified as a Winner. Refusal to fully complete, execute and return the Prize Claim Documents within the specified time will result in disqualification and forfeiture of prize. If a potential winner is disqualified for any reason, the prize will be awarded to one (1) alternate randomly-selected potential winner chosen from the same pool of eligible entries.

4. ELIGIBILITY: This Promotion is open to legal residents of the 50 United States, including the District of Columbia, age 18 and older at the time of entry. Employees of Sponsor, NBA Properties, Inc., the National Basketball Association and its member teams (collectively, the "NBA Entities"), its affiliates, subsidiaries, advertising and promotion agencies and their immediate family members and/or those living in the same household of each are not eligible to participate. This Promotion is void where prohibited, or restricted by law and is subject to all federal, state, and local laws and regulations.

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for ESPN Radio, a division of ABC Radio Network Assets, or Dell Marketing L.P., or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

5. PRIZES/APPROXIMATE RETAIL VALUES (ARV):

Total Maximum ARV of all prizes in the promotion: \$55,250. No cash equivalents (unless explicitly stated), prize substitutions or transfer of prizes will be allowed, except Sponsor reserves the right to substitute prize(s) of equal or greater value if a prize listed or any portion thereof is unavailable for any reason. No more than the advertised number of prizes will be awarded. Limit one (1) Weekly Grand Prize per household.

Week 1 Grand Prize (Maximum ARV: \$26,500): Week 1 Prize will include: up to a 17-day, 18-night trip for two (2) people (winner and guest) to up to seven (7) NBA Finals games; round-trip coach class air transportation for winner and one (1) travel companion from a major commercial U.S. airport near the winner's residence (as determined by Sponsor) to attend each NBA Finals game host city; ground transportation to and from airports; up to eighteen (18) nights of hotel accommodations for winner and guest (standard double-occupancy room).

Week 2 Grand Prize (ARV: \$16,850): Week 2 Prize will include: a 3-day 2-night trip for up to eight (8) people (winner and up to seven guests) to one (1) NBA Finals game (as determined by Sponsor); round-trip coach class air transportation for winner and up to seven (7) travel companions from a major commercial U.S. airport near the winner's residence (as determined by Sponsor); ground transportation to and from airport; two (2) nights of hotel accommodations for up to eight (8) people (four (4) standard double-occupancy rooms).

Week 3 Grand Prize (ARV: \$11,900): Week 3 Prize will include: a 3-day, 2-night trip for two (2) people (winner and guest) to one NBA Finals game; round-trip coach class air transportation for winner and one (1) travel companion from a major commercial U.S. airport near the winner's residence (as determined by Sponsor); ground transportation to and from airport; two (2) nights of hotel accommodations for winner and guest (standard double-occupancy room); and \$7,000 cash disbursed by check made payable to winner.

Items that are not included as part of a Grand Prize are: hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, local and long distance telephone calls, tips, gratuities, service charges or taxes, and all other charges and items not otherwise described above.

Travel companions on any prize trip must be eighteen (18) years of age or older, or if a minor, must be accompanied by a parent or legal guardian. other transportation companies or any other persons providing any of these services or accommodations. Sponsor shall not be liable for any loss or damage to baggage. Air transportation may not include government taxes, Passenger Facility Charge or September 11th Security Fee. Airline tickets are non-refundable/non-transferable and are not valid for upgrades and/or frequent flyer miles. Airline and hotel blackout dates may apply. All airline tickets are subject to the vagaries of flight variation, work stoppages, and schedule or route changes. ARV for travel prize may vary depending upon points of departure and destination and fare fluctuations. Sponsor reserves the right to structure travel route and select hotels in their sole discretion. Caution: Any attempt by an individual to deliberately damage any website or undermine the legitimate operation of the Promotion is a violation of criminal and civil laws and

should such an attempt be made, Sponsor reserves the right to seek damages from any such individual to the fullest extent of the law.
